### 10. Scope for additional services

The contracting authority may, at its own discretion extend this contract. Such extension shall be made under negotiated procedure. ### CONDITIONS OF PARTICIPATION

### 11. Eligibility

Participation is open to all legal persons participating either individually or in a grouping (consortium) of candidates which are established in a Member State of the European Union, in an official candidate country, or a country that is a beneficiary of the Instrument for Pre-Accession Assistance, in a Member State of the European Economic Area, a country of the Western Balkans region or a contributing third State, as authorized by Council Joint Action 2008/124/CFSP of 04 February 2008 on EULEX KOSOVO (see also item 29 below). Participation is also open to international organisations. The participation of natural persons is governed by the specific instruments applicable to the programme under which the contract is financed.

### 12. Candidature

All eligible natural and legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (ie, the leader and all other members) are jointly and severally liable to the Contracting Authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

## 13. Number of applications

No more than one application can be submitted by a natural or legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a natural or legal person submits more than one application, all applications in which that person has participated will be excluded.

#### 14. Shortlist alliances prohibited

Any tenders received from tenderers comprising firms other than those mentioned in the short-listed application forms will be excluded from this restricted tender procedure unless prior approval from the Contracting Authority has been obtained (see Prag 2.4.3.). Short-listed candidates may not form alliances or subcontract to each other for the contract in question.

#### 15. Grounds for exclusion

As part of the application form, candidates must submit a signed declaration, included in the standard

### 16. Sub-contracting

## 20. Initial period of implementation of tasks

The period of implementation of the tasks identified is **1 year** from the Commencement date (although the contract may be terminated at short notice. See article 19 of the special conditions of the draft contract).

The contracting authority may, at its own discretion extend this contract. Such extension shall be made under negotiated procedure. The contract may only be extended once, such that the duration of extension does not exceed the duration of the initial contract. #### SELECTION AND AWARD CRITERIA

### 21. Selection criteria

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- <u>1) Economic and financial capacity of candidate</u> (based on item 3 of the application form). In case of candidate being a public body, equivalent information should be provided.
- For the last three years (i.e. 2010, 2011 and 2012), the average annual turnover of the candidate must exceed by three times the annualised maximum budget of the contract; and
- 2) Professional capacity of candidate (based on items 4 and 5 of the application form)
- Has a professional certificate appropriate to this contract, such as being a Microsoft Gold Certified Partner and proof of Authorisation by the Vendor (Microsoft) that he is eligible to provide the services specified under this tender.
- At least 15 staff currently work for the applicant in fields related to this contract; and
- At least 40% of all staff working for the candidate this year in fields related to his contract are permanent.
- 3) **Technical capacity of candidate** (based on items 5 and 6 of the application form)
- The candidate has worked successfully on at least two projects with a budget of at least that of

this contract in fields related to this contract in the past three years (i.e. 2010, 2011 and 2012).

Previous experience which would have lead to breach of contract and termination by a Contracting Authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be reexamined to identify the eight best candidates. The only factors which will be taken into consideration during this re-examination are:

• The number of projects (with a budget of at least twice that of this contract in fields related to this contract) the candidate has successfully worked on during the past three years (i.e. 2010, 2011 and 2012).
