**1. The following changes have been introduced to the Technical Specifications:**

**Lot 5/Item 1: EUCI Compliant Class 2 storage safes/ for CLASS B SECURITY SAFES – Model 1**

**Previous text:**

- 40 Class B Security Safes, Model 1 must comply with EN 1047-1: fire protection for paper documents. Fire exposing period - 120 minutes plus cooling stage. Allows temperature increase of 170°C. Fireproof material on all sides.
- 60 Class B Security Safes, Model 1 must comply with EN-1047-2: fire protection for ICT equipment. Fire exposing period - 120 minutes plus cooling stage. Allows temperature increase of 50°C. Fireproof material on all sides.
- This safe must have
  - two shelves
  - 1 box on the bottom , maximum height 200mm in interior.

**Shall read now:**

- 40 Class B Security Safes, Model 1 must comply with EN 1047-1: fire protection for paper documents. Fire exposing period - 120 minutes plus cooling stage. Allows temperature increase of 170°C. Fireproof material on all sides.
- 60 Class B Security Safes, Model 1 must comply with **EN-1047-1**: fire protection for ICT equipment. Fire exposing period - 120 minutes plus cooling stage. Allows temperature increase of 50°C. Fireproof material on all sides.
- This safe must have
  - two shelves

- 1 box on the bottom , maximum height 200mm in interior.
